1. INTRODUCTION

1. The Canoe Marathon Selection Criteria must be read in conjunction with the Queensland Canoeing Team Selection Policy available at www.qld.canoe.org.au/about-us/policies.
2. To be considered eligible for selection an individual athlete must meet clause 5.1 of the Queensland Canoeing Team Selection Policy.

2. SELECTION EVENT/S

1. The Selection Event for the Queensland Canoe Marathon Squad will be the Queensland Canoe Marathon State Championships held on a date and location, as advised by Queensland Canoeing from time to time.
2. The Queensland Canoe Marathon State Team will be selected from the Queensland Canoe Marathon State Squad based on attendance at State Squad Development Camp and notified Selection Events.
3. The Canoe Marathon State Team will be announced a minimum of six (6) weeks, where possible, prior to the National Championships.
4. The selected Canoe Marathon State Team will represent Queensland at the Australian Canoe Marathon Championships on a date and location as advised by Australian Canoeing from time to time.

3. OBJECTIVE

1. The Selection Panel will be formed as per clause 4 of the Queensland Canoeing Team Selection Policy.
2. It is the objective of the Selection Panel to select persons to be invited to the Queensland Canoe Marathon State Squad and Team meeting the principles as listed in clause 1 of the Queensland Canoeing Team Selection Policy.

4. SELECTION CRITERIA

1. The Selection Panel will invite athletes to the Queensland Canoe Marathon State Squad should they finish in the top three places at the Queensland Canoe Marathon State Championships.
2. The Selection Panel may also select athletes to the Squad who demonstrate skill, ability and potential and will benefit from further development opportunities.
3. To be considered for selection to the Queensland Canoe Marathon State Team an athlete must attend the State Development Camps and compete in notified Selection Events.

5. PROCESS

1. Athletes have seven (7) working days from the date the invitation is sent to either accept or decline the invitation to the Queensland Canoe Marathon Squad/Team and sign the **State/Squad Team Member's Agreement**.

2. To accept the invitation to the State Squad/Team the athlete must pay the \$20 acceptance fee, sign the Team Agreement and return such to the Executive Officer, Queensland Canoeing Inc.
3. Athletes who fail to respond to the invitation by the date and time nominated by the Executive Officer, will be deemed not have accepted the invitation.
